Autobiography

Having spent the last two decades of my life serving in various roles within the law enforcement community, I not only have gained a worldview perspective within my discipline, but have also received hundreds of hours of post-secondary training directly related to this field. A major facet of my professional law enforcement experience stems from my time (15 years) in the military. As a military police officer in the United States Army, and later having served as a Criminal Investigation Division (CID) officer and trainer, my real-world experiences coupled with my formal training prepared me to serve in similar capacities in the civilian sector. Through these military experiences, I was required to attend and successfully complete numerous training course in an effort toward professional development and advancement. Courses ranged from basic criminology to advanced interrogation techniques. Beyond that, I also received training in data collection and analysis, specifically as it pertained to past and ongoing investigations.

Most recently, serving as a Sheriff for the city of Virginia Beach, I have had the privilege of providing some more intentional mentoring and coaching to those in correctional facilities; stemming my outreach from a Christian perspective. I have used my position to try to influence those who are in dire straits in an effort to help them redefine their lives and behavioral patterns. I also have spent the last 6 years volunteering as a mentor for the Hampton Roads Scared Straight program which assists teenagers who are likely headed down life pathways that are not going to end well for them or our society. While I have been able to earn my AA in General Studies, I believe my professional background provides the necessary foundation to pursue the BS in Criminal Justice.

- b. Served over 5 years as a volunteer with the Scared Straight program (Christian-based program), becoming a mentor and lay counselor for over 125 juveniles in correctional facilities. While serving as a mentor, I received coaching and guidance from a senior prison chaplain and a senior pastor from Norfolk, VA.

- a. Over 20 years of field experience in the military and civilian sectors serving the law enforcement community, as a field-level officer (patrol), basic and lead investigator (detective), and correctional officer.
- Completed basic, mid and senior level law enforcement training in the US Army as well as the City of VA Beach corrections course. (All resident courses totaling over 18 months of total formal training time)

5. Discuss how crime is measured and how crime data is collected

- a. Completed a 2-week training course for Special Reaction Teams (SRT) that required the mining, sifting, and analysis of thousands of data sets related to crime statistics and case management.
- b. Completed a 2-month resident course (Military Police Senior Leader) which focused on data driven deliverables within the scope of Law Enforcement Administration and Supervision. As corrections officer, provided regional data to regional superintendent on a monthly basis in order to better understand the crime and conviction trends associated with Virginia Beach.

6. Compare and contrast basic theories of criminology with Scripture

- a. Completed 20-hour training course from ACPE regarding prison ministries and how biblical principles impact conversion rates as well as the correlation between non-believers and repeat offenders. Volunteer for the VBPD "Every 15 Minutes" program.
- b. Worked directly with the lead Virginia Beach PD Chaplain to determine the commonalities found between case-loads, crime rates, case resolution rates, and crime categories as cross-referenced with those officers and offenders who identify as Christians. This research led to a published division-wide report resulting in some resource allocation adjustments for certain precincts.
