H. FINANCIAL AID

Awarded aid: The dollar amounts offered to financial aid applicants.

External scholarships and grants: Scholarships and grants received from outside (private) sources that students bring with them (e.g., Kiwanis, National Merit scholarships). The institution may process paperwork to receive the dollars, but it has no role in determining the recipient or the dollar amount Work study and employment: Federal and state work study aid, and any employment packaged by vour institution in financial aid awards.
